- 7. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 13 noon on 23th Apr 2021 (2078-01-10). at the office of Chandrakot RM, Shantipur Gulmi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of [Rs.45,00,000.00 (Rupees Fourty-Five Lakhs Only)], which shall be valid for 30 days beyond the validity period of the bid i.e. 120 days.
